A BILL

To provide for an extension of funding outreach and assistance for low-income programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Senior Savings Protec-
5 tion Act”.

6 **SEC. 2. EXTENSION OF FUNDING OUTREACH AND ASSIST-**
7 **ANCE FOR LOW-INCOME PROGRAMS.**

8 (a) STATE HEALTH INSURANCE ASSISTANCE PRO-
9 GRAMS.—Subsection (a)(1)(B) of section 119 of the Medi-

1 care Improvements for Patients and Providers Act of 2008
2 (42 U.S.C. 1395b–3 note) is amended—

3 (1) in clause (xiii), by striking “and” at the
4 end;

5 (2) in clause (xiv), by striking the period at the
6 end and inserting “; and”; and

7 (3) by adding at the end the following new
8 clause:

9 “(xv) for each of fiscal years 2026
10 through 2030, \$15,000,000.”.

11 (b) AREA AGENCIES ON AGING.—Subsection
12 (b)(1)(B) of such section 119 is amended—

13 (1) in clause (xiii), by striking “and” at the
14 end;

15 (2) in clause (xiv), by striking the period at the
16 end and inserting “; and”; and

17 (3) by adding at the end the following new
18 clause:

19 “(xv) for each of fiscal years 2026
20 through 2030, \$15,000,000.”.

21 (c) AGING AND DISABILITY RESOURCE CENTERS.—
22 Subsection (c)(1)(B) of such section 119 is amended—

23 (1) in clause (xiii), by striking “and” at the
24 end;

1 (2) in clause (xiv), by striking the period at the
2 end and inserting “; and”; and

3 (3) by adding at the end the following new
4 clause:

5 “(xv) for each of fiscal years 2026
6 through 2030, \$5,000,000.”.

7 (d) COORDINATION OF EFFORTS TO INFORM OLDER
8 AMERICANS ABOUT BENEFITS AVAILABLE UNDER FED-
9 ERAL AND STATE PROGRAMS.—Subsection (d)(2) of such
10 section 119 is amended—

11 (1) in clause (xiii), by striking “and” at the
12 end;

13 (2) in clause (xiv), by striking the period at the
14 end and inserting “; and”; and

15 (3) by adding at the end the following new
16 clause:

17 “(xv) for each of fiscal years 2026 through
18 2030, \$15,000,000.”.
