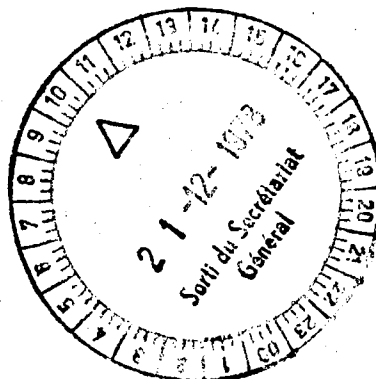

EXPLANATORY MEMORANDUM

1. By Council Regulation (EEC) No 265/78 of 7 February 1978¹, the Council made the importation into the Community of textile products originating in certain third countries subject to common rules for authorization and quantitative limitation, following the negotiation of agreements to that effect with the countries in question. The Annex to the Council Regulation establishes the distribution of the Community limits for 1978 among the Member States.
2. A number of the non-member countries concerned (Romania, Philippines, Thailand, Singapore, South Korea, Hong Kong) have officially asked for the distribution figures to be amended to bring them more in line with those countries' export opportunities on the various regional markets of the Community.
3. The Commission and the Member States have examined these requests in the appropriate committees. Some of the changes have been accepted by the Community and it is therefore necessary to amend the distribution figures published in the Annex to Council Regulation (EEC) No 265/78. Accordingly, the attached proposal for a regulation is hereby submitted to the Council for adoption as soon as possible.

Proposal for
Council Regulation (EEC)

amending Regulation (EEC) No 265/78 on
the importation of textile products originating
in certain third countries

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic
Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas agreements on trade in textile products covering the period
1 January 1978 to 31 December 1982 have been negotiated between
the Community and certain third countries, which under the terms of
these agreements, have accepted quantitative limitation of their exports
of certain textile products to the Community for the period in
question;

Whereas, pending the formal conclusion of these agreements and the
completion of the procedures required for their entry into force,
the Council, by Regulation (EEC) No 265/78¹, has
made the importation into the Community of textile products
originating in certain third countries subject to common rules for
authorization and quantitative limitation, until 31 December 1978;

Whereas following the request of the third countries concerned, the
Community has accepted certain changes in the distri-
bution between Member States of the quantitative limits
for 1978 set out in Regulation (EEC) No 265/78;

Whereas the Community should give effect to these changes and
the Annex to Regulation (EEC) No 265/78 must be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

The Annex to Regulation (EEC) No 265/78 is hereby amended as indicated in the Annex hereto.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.
