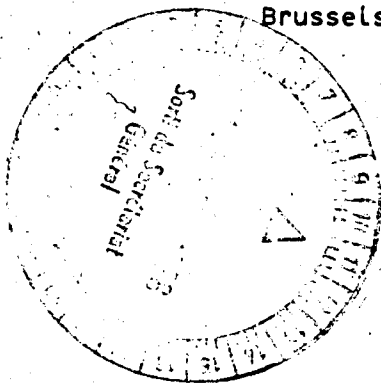

EXPLANATORY MEMORANDUM

In the framework of the present Tokyo Round the main industrialised countries have reached understanding on the objective of negotiating elimination of duties for commercial aircraft. These negotiations having not yet been terminated the Commission thinks that it is appropriate to prolong until 30.6.1979 the existing CCT duty suspension for mechanically propelled aircraft of an "unladen weight" exceeding 15.000 kg falling within subheading ex 88.02 B II c).

COUNCIL REGULATION (EEC)

temporarily suspending the autonomous Common Customs Tariff duty for mechanically propelled aircraft of an unladen weight exceeding 15 000 kilograms falling within subheading ex 88.02 B II c)

THE COUNCIL OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 28 thereof,

Having regard to the draft Regulation submitted by the Commission,

Whereas the autonomous duty on mechanically propelled aircraft of an unladen weight exceeding 15 000 kilograms should be totally suspended for the period 1 January to 30 June 1979.

HAS ADOPTED THIS REGULATION:

Article 1

From 1 January to 30 June 1979, the autonomous Common Customs Tariff duty for mechanically propelled aircraft of an unladen weight exceeding 15 000 kilograms, falling within subheading ex 88.02 B II c) shall be totally suspended.

Article 2

This Regulation shall enter into force on 1 January 1979.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
