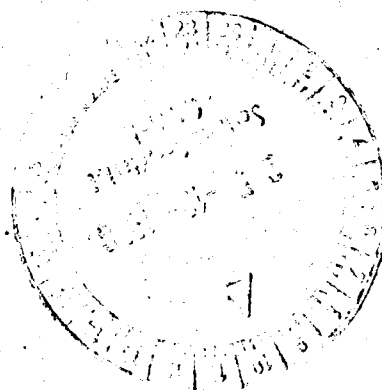

I. REASONS FOR THE ADDITIONAL FUNDS REQUESTED

1. Chapter 80, Article 800 (Projects for the improvement of agricultural structures provided for under Article 13 of Regulation No 17/64/EEC)

(a) Appropriations for commitment

At its 516th meeting, on 8 to 12 May 1978, the Council asked the Commission to take the requisite steps to ensure funding in 1978 and 1979 for the measures to improve production structures provided for by Regulation No 17/64/EEC. The amount called for by the Council is 70 m EJA.

The appropriations which have not yet been utilized for common measures in the 1978 Budget will be used to finance these measures by way of derogation from Article 6 of Regulation No 729/70. At the same time, the Commission has presented to the Council a proposal to amend the regulation in question.

(b) Appropriations for payment

No transfer is necessary. The 1978 requirements are amply covered by the appropriations for payment which have been automatically carried over from 1977 (54,5 m EJA) and the new appropriations entered in the 1978 Budget (26 m EJA). As can be seen in the last column of the appended table, there will even be a sum of 16 m EJA left at the end of the year; this will be carried over to 1979.

2. Chapter 82, Item 8202 (Marketing and processing of agricultural products)

(a) Appropriations for commitment

Following the same Council meeting on 8 to 12 May 1978 (see Article 3 of Regulation (EEC) No 1361/78), the third paragraph of Article 16 of Regulation (EEC) No 355/77 was amended to raise the estimated annual cost of this measure from 80 to 122 m EJA for the period from 1 January 1978 to 31 December 1982. An additional 42 m EJA has therefore to be found.

(b) Appropriations for payment

In view of the abovementioned requirement for 42 m EJA in additional appropriations for commitment and the estimated rate of payment of this amount over a five-year period, the requirement for payments in 1978 is put at 32 m EJA. An additional 28 m EJA will thus have to be found to supplement the present appropriations which stand at only 4 m EJA.

3. Chapter 89 (Special measures)

Finally, the appropriations for Article 890 (producer groups in the fruit and vegetable sector) and Article 894 (producer groups in the fisheries sector) will have to be supplemented in view of the applications for reimbursements made by the Member States, which are in excess of the budgetary estimates.

II. AVAILABLE APPROPRIATIONS

1. Chapter 81 (Common measures for the reform of agricultural structures)

The implementation of common measures has had less impact on EAGGF Guidance Section expenditure than anticipated. On the basis of the requests for reimbursement made by Member States which effected expenditure in 1977, the following volume of aid is requested for 1978:

(a) Item 8100 (Modernization of farms)

31,5 m EJA (instead of the 48,8 m EJA estimated)

(b) Item 8103 (Mountain and hill farming)

60,1 m EJA (instead of the 100,3 m EJA estimated).

A sum of 57,5 m EJA (in both appropriations for commitment and appropriations for payment) can therefore be released from these two articles and transferred to headings 800, 8202, 890 and 894 to cover their needs.

2. Chapter 83 (Common measures in particular sectors)

(a) Item 8350 (Wine sector - conversion premium)

In view of the reimbursement requested by France - which had effected expenditure in 1977 - and of the estimates made for Italy, reimbursements for 1978 are put at 13 m EJA (instead of the 33 m EJA estimated).

(b) Item 8370 (Eradication of brucellosis, tuberculosis and leucosis in cattle)

As provided in Article 29(1) of Directive 78/52/EEC, Directive 77/391/EEC will take effect on 1 January 1978. The appropriations entered in the 1978 Budget (39 m EJA) cannot therefore be used and the first reimbursements by the EAGGF Guidance Section will have to be made in 1979 (see Article 8 of Directive 77/391/EEC). The appropriations for commitment released from these two headings will amply cover the additional needs of Items 8000 and 8202.
