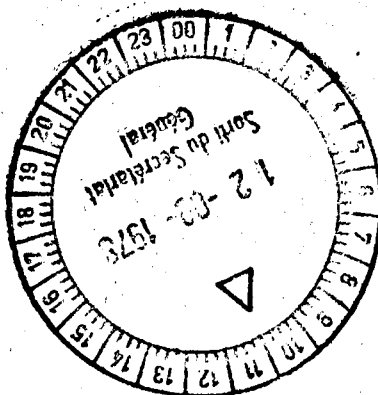

REASONS

(1) Transfer No 16/78

Negotiations for the renewal of the Lomé Convention will begin in September and are planned to last until June of next year. It was impossible to estimate the costs of these negotiations when the Preliminary Draft 1978 Budget was drawn up, i.e. in the spring of last year.

The following expenditure is estimated for the period from 18 September to 18 December:

2. Premises

With the exception of the ministerial and plenary meetings the entire negotiations will be conducted at the Manhattan Center where the Commission has conference rooms equipped for simultaneous interpretation.

Since five conference rooms will have to be set aside for the negotiations, other rooms will have to be hired for the meetings of experts which the Commission scheduled for the Manhattan Center some time ago.

The cost of hiring these rooms is estimated to be (four rooms at Bfrs 30 000 for 60 days)	<u>180 000</u>

The Commission asks the Budgetary Authority to authorize the transfer of 671 000 EUA from Chapter 101 (Contingency reserve) to Article 2550 (Conferences, congresses and meetings organized by the institution) of Chapter 25 since this amount cannot be found within Chapter 25, as the following table shows (see Annex I), eight twelfths of the appropriations in this Chapter having already been committed by 30 June. This amount cannot be found within Title 2 at this point in time as these appropriations have already been drastically reduced as a result of fluctuations in the EUA.

(2) Transfer No 17/78

By way of introduction it should be noted that the increase in appropriations for 1978 is mainly attributable to the much wider obligations which must be met by the Commission as a result of the implementation of the Verification Agreement concluded between the Community, seven of its Member States and the International Atomic Energy Agency (IAEA). The Agreement sets the Commission's activities in a world context within the framework of a United Nations specialized agency. The Commission is thus required to find funds to cover the costs of purchasing the following highly sophisticated equipment:

ten video-camera surveillance systems with a safeguard system 245 000 EUA

purchases connected with the operation of equipment in situ and relevant supplies (shockproof transport containers, SNAP and SAM 2 heads, UF₆, etc.) 100 000 EUA

particular items of non-destructive inspection equipment to monitor installations fabricating mixed oxide (plutonium/uranium) fuel elements and low- and high-enriched uranium fuel elements (two hexagonal units + electronics, two multichannel plutonium verification units, sample assay device) 85 000 EUA

procurement of equipment for processing data during inspection visits to nuclear installations in the Community 20 000 EUA

In order to meet its new obligations the Commission requires an appropriation of 450 000 EUA after deduction of 110 000 EUA for the scientific and technical work carried out by the JRC at Ispra. There is thus a shortfall of 250 000 EUA which the Commission requests be met by transfer from Chapter 101 (see Annex III).
