

COUNCIL DECISION**of 25 November 1980****appointing the members of the Consultative Committee of the European Coal and Steel Community****(80/1104/ECSC)**

Having regard to the Treaty establishing the European Coal and Steel Community, and in particular Article 18 thereof,
